We maintain and will continue to do so, complete, true and accurate books and records, up to date and precise related to our activities and commercial transactions, all in absolute compliance with the applicable regulations. All expenses are paid and properly documented with enough details and recorded as per Generally Accepted Accounting Principles and within the Law.
